Registered athletes for the trials are to report at the OCBC Arena Hall 4/5 by the stated timing. Kyorugi athletes shall be considered for the category based on their actual weight on the day of the weigh-in and not according to the weight submitted in the form as we do not want to disqualify any athletes. No weight allowance will be given.

Athletes who are injured on the day of the trials must submit a doctor's certified documentation on the day of the trials.

The player's undertaking form is also attached. The form must be signed by parents for players under the age of 21 years old. Players will not be allowed to participate in the trials if they do not comply with the administrative requirements. Players with medical history must provide medical clearance from their doctor.

Due to the Covid-2019 situation, the trials would only be open for observation by the registered accompanying coaches (**must be Level 2 qualified**) only. Temperature screening and travel declaration will be conducted and individuals who are unwell, on Leave of Absence, Stay-Home Notice or have recent travel history to mainland China, Daegu city or Cheongdo county in Republic of Korea, North Italy and Iran should not attend.

Please note that no photography and video recording will be allowed.
