- I, the applicant, understand and agree to the the following
- 1. The application for the World Taekwondo Global Management System (WT GMS) shall constitute an agreement by the applicant to be subject to and bound by the Singapore Taekwondo Federation's (STF) rules and regulations as set out in the latest consitution and bye-laws established by the Board.
- 2. All applicants shall pay an annual membership renewal fee as determined by the Board based on WT GMS fees. Membership renewal fees shall be paid at the point of registration or renewal. Applicants who have membership renewal fee arrears may be suspended or terminated based on the rules and regulations as set out in the constitution or by the decision of the Board.
- 3. All applicants are subjected and bound by the rules and regulations as set out in the consitution and any bye-Laws established by the Board which includes but are not limited to the following. The STF will institute disciplinary action including, but not limited to, suspension of any affiliate or member for breaching the rules and regulations any any bye-Laws.
 - a. All applicants are not to participate in non-STF recognised gradings.
 - b. Applicants are not to be involved in any events organized by clubs or associations not recognized or affiliated to the respective national sports bodies. Applicants invited by their friends or organizers are strongly advised to check with the STF before agreeing to accept their invitations if they are not sure if the events or activities are recognized or sanctioned by the national associations.
 - c. Applicants wishing to participate in an overseas competition/tournament/training/activities must apply in advance to STF for its consent. Applicants invited by their friends or organizers are strongly advised to check with the STF before agreeing to accept their invitations if they are not sure if the events or activities are recognized or sanctioned by the national associations.
 - d. Attire for international or local events need to be approved by STF

- Applicants have to ensure that they adhere to the latest uniform guidelines as stated in the Singapore Taekwondo Federation's website.
- ii. In general, only the national athletes representing Singapore in international events will be allowed to don the National Flag. All applicants should otherwise be wearing STF-approved doboks with "Singapore Taekwondo Federation" at the back and the STF logo on the left sleeve.
- e. Applicants who organise any inter-club events must receive prior approval and sanction from STF.
- 4. Applicants should pledge to undertake the following and they understand that failing which, disciplinary measures, ranging from warning to life suspension may be taken against them by the Singapore Taekwondo Federation.
 - a. To act in the best interest of all participants (althetes, officials, parents and other stakeholders) by
 - i. Respecting the rights of every individual regardless of race, language, religion, sex or physical ability,
 - ii. Placing their safety and welfare above all else,
 - iii. Reminding them of their responsibilities and
 - iv. Encouraging them to abide by the principles of fairplay and sportsmanship;
 - b. Act responsibly by
 - i. Striving to be well-prepared and current,
 - ii. Preparing sound, safe and fun program,
 - iii. Having a cordial relationships with otther coaches and
 - iv. Maintaining respectable relationship with the participants; and
 - c. Act with integrity
 - i. Maintaining the highest standard of professional behavior, personal conduct and appearance,
 - ii. Recognizing one's limitations and
 - iii. Observing the principles of fairplay and sportsmanship.
- 5. Applicants should adhere to the latest safe management measures and safe return to sport plan with guidance from STF's advisory and other guidelines from the relevant authorities.
