“National Athlete” means Athletes who have represented Singapore at:

- i. Major Games sanctioned by SNOC e.g. World/Asian Championships, Olympic/ Asian/ SEA Games etc
- ii. International and Regional Tournaments where Athlete competed representing Singapore.
- c) Have a minimum tenure of 24 months with the National Development Squad.
